2. Student Exchange for Seminar and Workshop:

Both colleges must invite each other's students in different seminar and workshop organized by any of the colleges.

3. Skill Development Activity:-

Both colleges must organize skill development program for students of both college and also invite each other students in it.

4. Physical Resource Sharing:-

Both colleges can share each other's physical resources whenever they needed.

5. Organization of One Mega Event:-

Both colleges must organize at list one mega event like conference, cultural event or sports event for both faculty and students or for society.

- Randhirsingh Bhadoriya Mahavidyalaya, Umred appoints Principal/ IQAC Coordinator herein referred to as Randhirsingh Bhadoriya Mahavidyalaya, Umred representative.

Financial Agreement

This MOU is not committing any financial agreement between both colleges.

Amendment

- (1) This MOU may be amended or revised at any time by mutual written consent of both colleges, and such amendment shall form an integral part of this MOU.
- (2) Such amendment or revision shall come into force on the date as may be determined by both colleges.

Entry Into Force, Duration And Termination

- (1) This MOU shall enter into force on the date of signing.
- (2) This MOU shall remain in force for a period of two (2) years and may be extended for another period of two (2) years by mutual written consent of the both colleges.
- (3) Either College may terminate this MOU at any time by giving written notification to the other College on its intention to terminate this MOU, six (6) months prior to the date of the termination.

(4) The termination of this MOU shall not affect the completion of any projects and programs in progress and not completed at the time of termination.
