**EDUCATION/ STUDENT & TEACHER EXCHANGE / EXTENSION ACTIVITIES /RESEARCH**

### Preamble:

This memorandum of understanding made on this 10<sup>th</sup> July, 2021 between Nagpur Shikshan Mandal's "Shri Binzani City College, Nagpur" and The Umred Academy of Arts & Sciences' "Mahila Kala Mahavidyalaya Umred, Nagpur".

Witnessed as follows:

**RECOGNISING** the mutual interest in the fields of academic and extension activities, faculty research, training & development, expertise exchange and dissemination of knowledge on a long term non-commercial basis, and also,

**HEREBY** agree to establish collaboration in terms of the field study and analysis during the pendency of MOU according to terms and conditions set out in the articles following hereunder,

The words "the two institutions" and "collaborating institutions" in the Memorandum of Understanding refer to "Shri Binzani City College, Nagpur" and "Mahila Kala Mahavidyalaya Umred, Nagpur".

Collaboration between the two institutions may be established within any field related to the Faculty of Arts of mutual interest and in particular academics, extension & research. Extension to other areas will be made through further amendments to the present Memorandum of Understanding.

**Article-2 : EXCHANGE OF STAFF AND STUDENTS:**

- 2.1 Faculty Exchange and Student Exchange activities will be engaged by both the respective institutions. It will be expected that at least One Unit / considerable portion will be completed by Faculty of both sides.
  - 2.1.1 Faculty and students of either institute, who wish to undertake a short-term programme or fieldwork/research work at the other institution will be assisted by the host institution in getting authorization, finding accommodation, library and laboratory facilities provided the programme is accepted by the home institution and by at least one supervisor from each institution.

There is a possibility of twinning faculty and students of the two Institutions in common research.
- 2.2 Parties will exchange proposals concerning the above mentioned activities, reasonably in advance of the proposed visit.
- 2.3 The facilities available in the respective institutions shall be extended for the students on mutually agreed terms and conditions.
- 2.4 Both the partnering institutes will conduct atleast One Faculty Development Program for Teaching and Non-teaching Staff in a year of One week duration.

**Article-3 : TRAINING**

- 3.1 **“Mahila Kala Mahavidyalaya Umred, Nagpur”** will provide facilities for practical training / Skill development programs / Sports / Cultural activities for students of Shri Binzani City College, Nagpur. The training fees, travel and/or living allowances to these students will be provided by Shri Binzani City College, Nagpur or the student itself. The selection of the student will be need-based.

Similarly students from **Mahila Kala Mahavidyalaya Umred, Nagpur** can also be sent for training to **Shri Binzani City College, Nagpur**.

For any collaborative venture, the partnering institutes shall have access to resources like Seminar Hall, Playground, Gymnasium, Library, English Language Laboratory, Psychological Counseling Center 'UMBARTHA', Innovation and ED Cell 'NAV ANKUR' etc.

**Article-4 : JOINT SUPERVISION OF STUDENT PROJECT:**

- 4.1 As part of the collaboration, the faculty of both institutes may jointly supervise the research projects of students.
- 4.2 The details for the projects of students will be worked out by the respective persons of both institutions.
- 4.3 The student should first submit a project proposal which has to be authorized by both institutions.
- 4.4 Both the institutes will hold intellectual property rights on any research or project being jointly done.
- 4.5 Publication of the same will be done in joint collaborations.



#### **Article-5 : Competitive Guidance Centre**

- 5.1 Competitive Guidance Centers of both the Institutes will jointly plan and conduct competitive guidance programs to nurture the students enrolled and their respective centers. The students of both the Institutes with prior permission of both the Principals can join any Competitive Exams related sessions / programs organized by partnering institutes.
- 5.2 For the purpose of competitive exam related training both the institutes shall encourage Faculty Exchange such that minimum 30% of the course content is covered by the concerned Faculty.
- 5.3 Both the Institutes shall ensure Conduction of Mock Tests where each institute shall conduct minimum one mock test for the students of the partnering institute.
- 5.4 Book Exchange and Book loan facility shall be extended to the partnering institute students with prior permission of the Principal of both the Colleges.
- 5.5 Teachers of the partnering institutes shall jointly create e-resources specifically for competitive examinations and the same shall be applied to claim IPR. Minimum two such IPRs per year are expected from this MoU.

#### **Article-6 : LINK MANAGEMENT AND ADMINISTRATION:**

Negotiation, implementation and co-ordination of the Memorandum of Understanding fall under the responsibility of both, Principal , “Mahila Kala Mahavidyalaya Umred, Nagpur” and the Principal, Shri Binzani City College, Nagpur The Memorandum of Understanding will take effect from the date it is signed by the Principal Shri Binzani City College, Nagpur ” and Centre Head, “Mahila Kala Mahavidyalaya Umred, Nagpur”.

#### **Article-7 : GENERAL PROVISIONS:**

- 7.1 The two institutions will carry out joint research as a follow up to this Memorandum of Understanding. The activities must be carried out under appropriate laws and regulations existing in the country.
- 7.2 The two institutions shall initiate an exchange of research publications, publication lists and other official publications. This will be provided with adequate security as for as intellectual property laws are concerned.
- 7.3 All publications resulting from the collaboration between the two institutions will be mentioned in the research reports of the institutions. Likewise, this Memorandum of Understanding must also be mentioned in all formal presentations, which result from the collaboration under the terms of this Memorandum of understanding.
- 7.4 This Memorandum of Understanding is signed subject to appropriate authorisation on both sides.

**Article 8 :** “Mahila Kala Mahavidyalaya Umred, Nagpur” will have (affiliation) recognized centre to the “Shri Binzani City College, Nagpur and can initiate technical manpower training courses jointly.



**Article-9 : NON-DISCLOSURE:**

In case of joint research and consultancy projects have taken up by Principal "Shri Binzani City College, Nagpur" and "Mahila Kala Mahavidyalaya Umred, Nagpur", no party will disclose any investigation to media/any unauthorized person from each institute in any form whether electronic/print without mutual consent and approval by coordination Committee.







**Article 10 : SETTLEMENT OF DISPUTES:**

Any differences or dispute between the parties concerning the interpretation and /or implementation and/or application of any of the provision of this Memorandum of Understanding shall be settled amicably through mutual consultation and/or negotiation between the Parties. In case, the dispute occurred between both the parties and if the same is not resolved through negotiation or by adopting amicable measures, in that case, the matter will be settled through Arbitration and the Arbitrator will be appointed with the mutual consent of both the parties, without reference to any tribunal or court at Nagpur only.

**Article-11 : VALIDITY PERIOD:**

This MOU shall be valid for **three years** from the date of signing. At the end of the validity period of the MOU, a fresh MOU with similar/modified terms may be considered for signing.
