

Binzani Mahila Mahavidyalaya, Nagpur and other experts) of students of Mahila Kala Mahavidyalaya, Umred, and/or outside the college, if such an event is organized by Mahila Kala Mahavidyalaya, Umred. 
GOVERNING LAW:
